Minutes Approval	• April 20, 2023- Approved
Presentations	 Rob Hart of the NWS provide an overview of the short/long range forecast. Southern half of Gallatin County has dry conditions but should improve. Precipitation is at 100-130% of normal. 6-10 day temps likely to be below normal, above average precipitation with intermittent storms. Typical to slightly warmer July-Sept but frequent storms. Entering Fire Season with below normal potential to significant wildfire season July-September in Gallatin County Anthony Cochenaur from Hoplite Industries presented lessons learned from the MSU Ransomware attack. No persistent impacts to critical infrastructure. Lessons Learned included focusing on: Exposure management, use of cyber automation, blocking anonymizing services, identification of stolen credentials, manage vulnerabilities and constant monitoring. Hoplite will consider various resources to improve Phishing awareness and trends in interagency sharing during critical events.
Discussion Items	 Hazmat Team Deployment Changes- Patrick outlined possible changes to the MT DES response protocols based on incident in Missoula County and is working on clarification. New policy appears to make the requesting agency responsible for costs. Future requests to DES to be handled by Emergency Management.
