Emergency Management – Patrick Lonergan	<ul> <li>Patrick gave an overview on where the MPI Plan is in the revision process. There are two "sub" groups, one focusing on Pre-Hospital and the other focusing on health care facilities. The two groups are just starting to work on the process and will be meeting at the end of February. Once the two groups have worked on their focus areas, the group will come back together and merge them.</li> <li>Patrick explained that the DNRC has their final Feasibility Study back for an Farky Warning System on Middle Grock Dam. The study assentially</li> </ul>
	<ul> <li>an Early Warning System on Middle Creek Dam. The study essentially said that a system is beneficial. The county is working on several grant/funding possibilities to support this project.</li> <li>Patrick advised that the PrimalQuest Endurance Race will be held in Big Sky at the end of June. He advised there is a meeting with Public Safety agencies in the area to ensure everything is coordinated. During the same two weeks as the race, the Walley Byam group will be in Bozeman for their international get together. They are estimating around 5,000 people. So there is a potential for the medical system to become strained during this period.</li> <li>Patrick handed out a final draft of the sheltering plan annex of the Gallatin County EOP. He has been working with the Red Cross to get everything correct in it, and it should be pretty close.</li> <li>With the assistance of Northwestern Energy, the two Civil Defense Sirens were removed a couple weeks ago. It was quite a process to get</li> </ul>
411	everything disassembled and moved, and thanks to NWE.

They are working on identifying what capability exists in the community including the hospital and other private health care facilities in the county. The goal is to identify what other facilities can care be provided at, to what level, and what supplies do they maintain. They will be conducting a survey in the near future to obtain this information. Pam also advised that there is a medical registry system that may tie into this, but they are waiting on the state to bring the</li> </ul>
