Patrick will be meeting with Larry Watson next week with the evaluation results to get the award process completed. Everyone was very impressed with what was proposed. It also looks like there will be some side benefits from the proposed solutions for the rest of the county. Jim Oberhofer, Bryan Connelley, Frank Smith, and Patrick Lonergan were on the review panel. Patrick let the group know that there is an increase in the match grant the emergency management receives for the fiscal year 2010. Emergency Management is working with 911 on some projects to utilize this funding. There will be some planning grant funding available around October.
	 There will be some planning grant funding available around October. Patrick is hoping to utilize this for updating and completing some of the local plans. VOAD has been discussing among their groups who is best suited for certain functions and has the ability to take them on. The United Way and the Help Center have agreed to coordinate spontaneous volunteers. They have been working through the best way to do this. Christina explained some of the issues they are addressing that came up at the explosion such as volunteer updates, information flow, and alternate communications methods. They also discovered that some phone systems have 211 blocked. She stated that over the next couple months they will be firming the process up and be ready to take it on. She advised that once they figure out their internal processes, they will be ready to work with Patrick to help develop a county EOP annex to address this. Norm and Christina advised that VOAD is also working on how to assist with Donation Management. This hasn't been narrowed down, but they are working on it. Patrick advised that emergency management has migrated to their new website. It is still located at www.ReadyGallatin.com. Patrick advised that the HazMat plan that AHAD reviewed and updated
