Emergency Management	<ul> <li>Patrick let everyone know that the county received the award letter from the state for planning money. The award was for \$36,922.77 to be utilized towards Emergency Operations Plan updates. The group discussed briefly some areas that the money can be used towards. Patrick stated that he would come back to AHAD with the contractor solicitation to help define the scope of the project.</li> <li>Patrick let the group know that due to the Grizzly Bear re-introduction to the threatened species list, the Special Use Permit has been delayed. As such, the system will not be installed until next summer. Patrick then showed photos of some of the components and the final system design.</li> <li>Patrick let the group know that the state is in the process of revising the State Strategic Plan. This is the plan that determines the spending priorities for homeland security funding. The survey will be available</li> </ul>
	within the next month. They only want 1 survey from each county. When that is available, Patrick will fill out the basic portions, then send the draft around to the different disciplines for feedback.

Unified Health Command	• Betty advised that the county is seeing influenza. While this is not being tested in patients, it is assumed to be influenza. Last week they had 60 cases, this week 400 cases. Seasonal Flu Vaccine has run out because the production has been shifted to make H1N1 vaccination. The Health Department is have a tough time predicting what Gallatin County will be getting and when in terms of H1N1 vaccinations. They generally do not hear more than a day or two before it arrives. They got their first 500 doses last week, but don't know when they will get their next shipment, or how many doses it will be. The distribution is based on a complex algorithm. The first allotment has been distributed to local care providers based on a percentage of their projected need. The Health Department will be holding a first responder H1N1 immunization clinic on Saturday (10/17) from 9:00 until 11:00 at the Health Department. If you have not been receiving H1N1 information directly from the Health Department, and wish too, please call them at 582-3100. When they get more doses available, they are willing to come out and do vaccination clinics throughout the county upon request.
