Exercise Follow-up
 Active Shooter Extraction – A discussion was held regarding
the variables and potential tactics that may be utilized in an
active shooter situation for removing injured people. It
appears the need for a larger discussion between law, fire
and ems would be valuable to discuss the different tactics
and what the medical side is prepared/ willing to do. GCEM
will setup a meeting on this subject.
 The question was asked if patients were allowed to bypass
Bozeman Health in an MCI. The group felt that was currently
allowed. Following the meeting Patrick followed up with Dr.
Lowe. He advised that patient bypass of the Bozeman Health
ER is an available option for an MCI setting. As with any
patient transport, patient bypass should be coordinated
between the ER and the Transport Officer.
 CISM Contacts – The question was asked if there was a
central state level coordinating agency for CISM. Simple
answer is no. Everything locally pointed back to Carol
Burroughs and Travis Munter. GCEM was tasked to get with
them and see if a broader contact list could be obtained and
added to the EMP.
 National Guard Resources – Patrick checked with the state on
what the planning assumptions would be for Montana
National Guard air resources. In theory resources could be
accessed directly through the state or through AFRCC. If
approved, deployment would look like: For helicopters, if an
airframe and pilot was available in Helena, likely would be 2-3
hours before arrival in Bozeman. For C-130, if crew and
airframe were available, would take 2 hours to configure
prior to liftoff from Great Falls. C-130's can be configured for

- 72 patients, however Montana does not have the medical configuration equipment (mainly litters).
- Reunification Process The group talked about our current reunification process that focuses on large spread incidents and isolated events where the focus in more on separated families. The Red Cross has taken on a larger role at the national level with reunification as of March. Our local chapter has interest in taking the lead on expanding our Gallatin County's plans. It was decided to move forward with broadening our current plans on reunification.
- O Joint Information Center We identified that it would be good to spend some time refining our Joint Information System to ensure we are all on the same page and supporting each other. We decided it is time to get the regular public information people together for a discussion. We also set a goal to develop a local government media guide to help educate new reporter when they arrive instead of during an incident.
- Coordination of Resource Move up We discussed that how
 we coordinate out of area resources coming into the area
 either to backfill or support the ongoing incident. Everyone
 agreed that we needed to define that function and add it to
 our plans. GCEM was tasked to coordinate a future meeting
 on that topic.
- Patrick reported that the current Emergency Management Plans up for review are available (<u>Click Here for Files</u>). Take a look and send any comments to Patrick.
- MSU Extension has interest in putting on some animal rescue/ evacuation training here in Gallatin County. Chief Lindroth talked about what those option may look like and the amount of work that could be involved. The group felt there would be enough interest in a 1 day awareness type class. Ron will check with Jeanne Rankin and see what the options are.

Updates

- The vendor award for the Hazard Mitigation Plan should be made shortly. Vendor will start on July 1.
- 6CV will be heading to Kalispell for its update on May 2nd. Should be back in mid June.
- Patrick reported that the Situation Analyst Montana homeland security grant was approved for hosting in FFY18.
- The group talked with Phillips66 about the tank work currently being conducted off Griffin. With the many new officials in the area we thought it would be good to have a meeting with Phillips66 and Exxon to make sure everyone is on the same page and there aren't any wrong assumptions if anything were to happen there. GCEM was tasked with setting up a meeting.
- Patrick reported that an initial discussion on evacuation standardization in Montana took place at the Wildfire Leadership

	Conference. A Proposal consisting of a Warning level and an Evacuation or Shelter in Place level was sent to Montana Sheriffs and Peace Officers. It sounds like the proposal was well received and hopefully a Montana Best Practice for Evacuations will come out of it.
