MEMORANDUM OF UNDERSTANDING  
BY AND BETWEEN  
THE MONTANA WING CIVIL AIR PATROL

GALLATIN COUNTY SHERIFF'S OFFICE

1. **Purpose.** The Gallatin County Sheriff's Office (GCSO) and the Gallatin County Disaster and Emergency Services (GCDES) wish to utilize the services of the Civil Air Patrol (CAP) and its volunteers for the public good. This is an addendum to the CAP memorandum of understanding (MOU) between Montana Disaster and Emergency Services (MT DES) and Montana Wing Civil Air Patrol (MT CAP), Registration No. **08-005-RMR-MT-DES**. This addendum does not, in and of itself, create any legal obligation among the parties or signatories.
2. **Authority.** In accordance with CAP MOU Registration No. **08-005-RMR-MT-DES**, paragraph 2.b.(2) *Other State or Local Agencies*, this addendum incorporates the terms, conditions, acknowledgments, and understandings of the parent MOU, a copy of which is attached hereto and acknowledged by all parties by their signature below, by which GCSO and GCDES may request and receive CAP mission support. GCSO, GCDES, and MT CAP will be controlled and subject to all the terms, conditions, acknowledgments, and understandings as set forth in the MOU and the additional requirement of Paragraph 3 of this MOU. All previous agreements and understandings, if any, are superseded by this agreement.
3. **Reimbursement.** Reimbursement to MT CAP for missions will be as follows:
  - a. **Reimbursement for Corporate Missions.** When reimbursement is required to MT CAP for missions performed under this addendum, such reimbursement shall be made directly to MT CAP and is limited to the rates established in the current Civil Air Patrol Regulation 173-3, *Payment for Civil Air Patrol Support*. The current rate is \$37.00 per hour plus actual fuel and oil costs.




