CENTURYTEL OF MONTANA, INC., an Oregon corporation ("CenturyTel") at 290 N Main, Kalispell, MT (406) 758-1502, agrees to sell and install, and Gallatin County, ("Customer") 311 W Main, Bozeman, MT (406) 582-3000, agrees to purchase, the telecommunications equipment specified on Schedule A to this Agreement ("Equipment"), in accordance with and subject to the terms and conditions of this Telecommunications Equipment Sales and Installation Agreement ("Agreement"), which is entered into by CenturyTel and Customer on January 28, 2009. The installation date and installation location for the Equipment, and the Equipment price, shall be as specified on Schedule A.

WARRANTIES AND DISCLAIMERS. Century Tel does not warrant that the operation of the Equipment will be uninterrupted or error free. CENTURYTEL MAKES NO EXPRESS OR IMPLIED WARRANTIES OF ANY KIND, INCLUDING THOSE OF MERCHANTABILITY, DURABILITY AND FITNESS FOR A PARTICULAR PURPOSE OR USE WITH RESPECT TO THE EQUIPMENT, ANY WARRANTIES OF MERCHANTABLITY OR QUALITY OF COMPUTER PROGRAM(S), INFORMATIONAL CONTENT OR ACCURACY, PARTICULAR PURPOSE OR SYSTEM INTEGRATION, AND CENTURYTEL EXPRESSLY DISCLAIMS, AND CUSTOMER EXPRESSLY WAIVES, ANY SUCH WARRANTIES. CENTURYTEL EXPRESSLY DISCLAIMS, AND CUSTOMER EXPRESSLY WAIVES, ANY WARRANTY AGAINST INFRINGEMENT AND AGAINST INTERFERENCE WITH CUSTOMER'S USE OR ENJOYMENT OF ANY INFORMATION AND/OR COMPUTER PROGRAMS. CUSTOMER DECLARES AND ACKNOWLEDGES THAT THE FOREGOING DISCLAIMERS AND WAIVERS HAVE BEEN BROUGHT TO THE ATTENTION OF CUSTOMER AND EXPLAINED IN DETAIL TO CUSTOMER AND THAT CUSTOMER HAS VOLUNTARILY AND KNOWINGLY CONSENTED TO THE FOREGOING DISCLAIMERS AND WAIVERS. Customer will be entitled to the benefit of any applicable manufacturer's warranties and, to the extent assignable, such warranties are hereby assigned by CenturyTel for the benefit of Customer and Customer shall take all reasonable action to enforce such warranties where available to Customer. Manufacturer warranty is attached to this agreement as Schedule B.

Inside Wiring. All inside wiring is to be provided by Customer. Performance of the Equipment and data transmission quality may be affected by faulty wiring. CenturyTel recommends that customer use a contractor that is certified to install Category 5e (or higher standard) wiring, and that Customer verify that such wiring, as installed, will support all applications and data transmission speeds Customer intends to use.

- 1. Sales Price and Payment Terms. CenturyTel's prices for the Equipment and installation are specified on Schedule A. All charges shall be paid within thirty (30) days after the date of the invoice. Prices quoted in this Agreement shall be valid for ninety (90) days from the date this Agreement is signed by CenturyTel representatives and delivered to Customer, after which time prices for the Equipment may change. CenturyTel shall apply a service charge of 1.5% per month (or, if less, the highest percentage allowed by law) on any unpaid balance not received by CenturyTel within thirty (30) days of the invoice date. To secure Customer's payment obligations under this Agreement, Customer grants CenturyTel a security interest in the Equipment. Customer agrees to sign a financing statement(s) covering the Equipment or other appropriate document(s) in order to perfect CenturyTel's security interest in the Equipment, if requested by CenturyTel.
- 2. <u>Taxes and Fees</u>. Prices do not include taxes or fees, of any kind, established by governmental authorities. Customer shall pay all such applicable taxes and fees when billed by CenturyTel. Alternatively, Customer may supply CenturyTel a valid tax exemption certificate in a form satisfactory to CenturyTel.
- 3. Customer Responsibilities. As a condition to CenturyTel's performance of its obligations hereunder, Customer agrees, at no charge to CenturyTel, to: (a) furnish and allow CenturyTel unrestricted use of Customer's site and the Equipment in order for CenturyTel to fulfill its obligations hereunder during the term of this Agreement; (b) provide reasonable working space and facilities, including heat, light, ventilation, telephone service, electrical current, trash removal and other necessary utilities for use by CenturyTel designated personnel, and adequate secure storage space, if required, for equipment and materials; (c) prepare the installation site in accordance with CenturyTel's standard physical and environmental requirements; (d) be solely responsible for ordering and coordinating with the local telephone company and/or applicable service provider for the installation and provisioning of all services required; (e) be solely responsible for payment to the appropriate utility or service provider for all utility and/or service charges, including, but not limited to, charges for telecommunications services; (f) provide any information and/or documentation that CenturyTel reasonably requests from Customer and that is necessary for CenturyTel to properly perform any of its obligations hereunder, which information shall be provided by Customer in the form and by the dates reasonably specified by CenturyTel; (g) cooperate with and assist CenturyTel in coordinating its work hereunder with work being performed by Customer or other contractors of Customer, such that CenturyTel's performance of its obligations hereunder can progress without interruption to the maximum extent practicable; (h) complete such other requirements for raceways, borings and cuttings, trenchings, conduit, variances and rights-of-way if required by CenturyTel for CenturyTel's performance of its obligations hereunder; (i) be solely responsible for the protection and operation of the Equipment and related systems, including all software and other parts thereof; (j) be solely responsible for data backups and data storage; (k) ensure that its personnel are available to receive delivery of the Equipment at the installation site, at a date and time to be determined between CenturyTel and Customer (risk of loss and damage to the Equipment shall pass to Customer upon delivery of the Equipment to Customer; provided, however, that CenturyTel shall be, subject to the limitations of liability and all other provisions of this Agreement, responsible for any damage to the Equipment caused by CenturyTel during installation of the Equipment); and (1) provide adequate security for its site and provide CenturyTel designated personnel access to its site during the times specified by CenturyTel as may be reasonably necessary for CenturyTel to perform its obligations under this Agreement. CenturyTel personnel shall comply with Customer's reasonable site and security regulations.

CUSTOMER UNDERSTANDS THAT LOSS OF DATA AND/OR INFORMATION MAY OCCUR AS A RESULT OF USE OF THE EQUIPMENT. CUSTOMER SHALL MAKE EXTERNAL BACKUP COPIES OF ALL DATA AND INFORMATION STORED IN ANY COMPUTER OR OTHER DEVICE CONNECTED TO THE EQUIPMENT PRIOR TO COMMENCEMENT OF SERVICES BY CENTURYTEL. Customer shall be responsible for any use of the Equipment by Customer or others, or in Customer's operations. Customer shall use the Equipment only in accordance with applicable manufacturer specifications. Customer is responsible for establishing back-up, review and other procedures and controls appropriate to protect against loss or error resulting from use of the Equipment. Customer represents and warrants that any computer or other device identified to CenturyTel or its agents or contractors for performance of services under this Agreement is owned exclusively by Customer, and that Customer has all rights necessary to authorize performance of such services.

- 4. <u>Subcontract</u>. Customer acknowledges and agrees that CenturyTel is merely a distributor of Equipment manufactured by third parties, and Customer agrees that CenturyTel shall have the right to engage the assistance of such manufacturers or others and/or subcontract portions of its installation obligations hereunder to such manufacturers or other third parties, in the performance of its obligations hereunder.
- 5. Exclusions. The services provided by CenturyTel under this Agreement do not include any of the following: furnishing supplies which are not part of the Equipment or furnishing material therefore; electrical work external to the Equipment; work or supply of material related to maintaining a proper environment at Customer's site; and/or providing any goods or services not expressly described in this Agreement as being provided by CenturyTel.

6. Software License. The Equipment may be or may contain software. In some cases the Equipment manufacturer (CenturyTel's vendor) has embedded such software into the hardware as an integral part of the Equipment. All software provided hereunder remains the property of, and full ownership shall remain vested in, the creator, developer, manufacturer, author or licensor, whichever the case may be. If required by the creator, developer, manufacturer, author or licensor, Customer must obtain a license to use such software, which license may contain specific terms and conditions for such use. These specific terms and conditions for use are governed entirely by said creator, developer, manufacturer, author or licensor and shall be adhered to by Customer. Upon the requirement of such creator, developer, manufacturer author or licensor, such license shall be executed by Customer as required and shall become a part of this Agreement by reference.

7. Miscellaneous.

- (a) The laws of the state of Montana shall govern the interpretation of this Agreement. If any of the provisions of the terms and conditions contained herein shall be held to be invalid or unenforceable in any jurisdiction in which these terms and conditions apply, such invalidity or unenforceability shall not invalidate or render unenforceable any other term or condition, but rather these terms and conditions shall be construed and enforced accordingly. In the event of any such invalidity or unenforceability of any provision, the parties shall promptly cooperate to replace such provision with a valid and enforceable provision that achieves the same result as the invalid or unenforceable provision, to the maximum extent permitted by law.
- (b) CenturyTel shall not be responsible for performance if its performance is prevented by acts or events beyond CenturyTel's reasonable control, including but not limited to power failures, electrical power surges or current fluctuations, nuclear or other civil or military emergencies, or acts of legislative, judicial, executive, or administrative authorities.
- (c) Any failure of a party to assert any right under this Agreement shall not constitute a waiver or termination of that right, this Agreement, or any of this Agreement's provisions.
- (d) Customer shall not assign or transfer any interest in this Agreement without the prior written consent of CenturyTel, which consent shall not be unreasonably withheld; provided, however, that CenturyTel may assign and/or transfer this Agreement to any parent, subsidiary, or successor, and CenturyTel shall have the right to subcontract all or any portion of its installation obligations hereunder to a third party.
- (e) The respective obligations of Customer and CenturyTel under these terms and conditions, which by their nature would continue beyond the termination, cancellation, or expiration hereof, shall survive termination, cancellation, or expiration hereof.
- (f) Except as otherwise provided in this Agreement, any notice or demand to be given under this Agreement shall be delivered in person or by United States certified mail, return receipt requested, and addressed as specified on Schedule A or to such other address as a party may specify in accordance herewith. Notice shall be effective upon receipt.
- (g) No provision of this Agreement shall in any way inure to the benefit of any third person (including without limitation the public at large) so as to constitute any such person a third party beneficiary of the Agreement or of any one or more of the terms hereof, or otherwise give rise to any cause of action in any person not a party hereto.
- (h) If any suit or action is instituted or prosecuted to interpret or enforce any provision of this Agreement, the prevailing party in such suit or action shall be entitled to recover from the other party costs, expenses and reasonable attorney fees incurred by such prevailing party in connection with such suit or action, in addition to all other sums allowed by law and this Agreement, both at trial and on appeal.
- (i) This Agreement may be executed in one or more counterparts, all of which taken together shall constitute one instrument. Each party to this Agreement agrees to accept a facsimile signature on behalf of the other party in lieu of an original signature; provided however, that either party may request, and the other party shall provide, an appropriate original signature following acceptance by such party of a facsimile signature.
- (j) This Agreement (which adheres to the terms and conditions of the Gallatin County RFP for 9-1-1 Customer Premise Equipment) represents the entire Agreement between the parties, is the final, complete exclusive statement of the provisions thereof, and supersedes and terminates any prior agreement, understanding, or representation between the parties with respect thereto, whether written or oral. Without limiting the generality of the preceding sentence, no provision of any purchase order or other document issued by Customer, whether before, on or after the date of this Agreement, shall modify or supplement in any way any provision of this Agreement.

Buyer's notice to Seller referred to above must be delivered in writing, by telegraph, by facsimile transmission, by other means of electronic transmission or by telephone (confirmed by other means set forth herein) within the first year after acceptance. Seller shall use its best efforts to correct any performance deficiencies within the shortest possible time.

C. If any Equipment fails to meet the foregoing warranties, Seller shall correct the failure at its option (i) by repairing the defective or damaged part or parts thereof, or (ii) by making available at Seller's factory any necessary repaired or replacement parts. Any repaired or replacement part furnished hereunder shall be warranted for the remainder of the warranty period of the Equipment in which it is installed. Where such failure cannot be corrected by Seller's reasonable efforts, the parties will negotiate an equitable adjustment in price. Seller's warranty applies only to the repair or replacement of faulty or non-conforming material and labor to remove and replace such faulty material shall be provided at Buyer's expense.

All warranty repairs are performed at no cost, FOB plant. Seller will prepay return freight. Seller reserves the right to repair or replace any equipment found to be defective.

- D. As a condition to CenturyTel's performance of its obligations hereunder, Customer agrees, at no charge to CenturyTel, to: (a) furnish and allow CenturyTel unrestricted use of Customer's site and the Equipment in order for CenturyTel to fulfill its obligations hereunder during the term of this Agreement; (b) provide reasonable working space and facilities, including heat, light, ventilation, telephone service, electrical current, trashremoval and other necessary utilities for use by CenturyTel designated personnel, and adequate secure storage space, if required, for equipment and materials; (c) prepare the installation site in accordance with CenturyTel's standard physical and environmental requirements; (d) be solely responsible for ordering and coordinating with the local telephone company and/or applicable service provider for the installation and provisioning of all services required; (e) be solely responsible for payment to the appropriate utility or service provider for all utility and/or service charges, including, but not limited to, charges for telecommunications services; (f) provide any information and/or documentation that CenturyTel reasonably requests from Customer and that is necessary for CenturyTel to properly perform any of its obligations hereunder, which information shall be provided by Customer in the form and by the dates reasonably specified by CenturyTel; (g) cooperate with and assist CenturyTel in coordinating its work hereunder with work being performed by Customer or other contractors of Customer, such that Century Tel's performance of its obligations hereunder can progress without interruption to the maximum extent practicable; (h) complete such other requirements for raceways, borings and cuttings, trenchings, conduit, variances and rights-of-way if required by CenturyTel for CenturyTel's performance of its obligations hereunder; (i) be solely responsible for the protection and operation of the Equipment and related systems, including all software and other parts thereof; (i) be solely responsible for data backups and data storage; (k) ensure that its personnel are available to receive delivery of the Equipment at the installation site, at a date and time to be determined between CenturyTel and Customer (risk of loss and damage to the Equipment shall pass to Customer upon delivery of the Equipment to Customer; provided, however, that CenturyTell shall be, subject to the limitations of liability and all other provisions of this Agreement, responsible for any damage to the Equipment caused by CenturyTel during installation of the Equipment); and (l) provide adequate security for its site and provide CenturyTel designated personnel access to its site during the times specified by CenturyTel as may be reasonably necessary for CenturyTel to perform its obligations under this Agreement. CenturyTel personnel shall comply with Customer's reasonable site and security regulations.

CUSTOMER UNDERSTANDS THAT LOSS OF DATA AND/OR INFORMATION MAY OCCUR AS A RESULT OF USE OF THE EQUIPMENT. CUSTOMER SHALL MAKE EXTERNAL BACKUP COPIES OF ALL DATA AND INFORMATION STORED IN ANY COMPUTER OR OTHER DEVICE CONNECTED TO THE EQUIPMENT PRIOR TO COMMENCEMENT OF SERVICES BY CENTURYTEL. Customer shall be responsible for any use of the Equipment by Customer or others, or in Customer's operations. Customer shall use the Equipment only in accordance with applicable manufacturer specifications. Customer is responsible for establishing back-up, review and other procedures and controls appropriate to protect against loss or error resulting from use of the Equipment. Customer represents and warrants that any computer or other device identified to CenturyTel or its agents or contractors for performance of services under this Agreement is owned exclusively by Customer, and that Customer has all rights necessary to authorize performance of such services.

- 4. <u>Subcontract</u>. Customer acknowledges and agrees that CenturyTel is merely a distributor of Equipment manufactured by third parties, and Customer agrees that CenturyTel shall have the right to engage the assistance of such manufacturers or others and/or subcontract portions of its installation obligations hereunder to such manufacturers or other third parties, in the performance of its obligations hereunder.
- 5. Exclusions. The services provided by CenturyTel under this Agreement do not include any of the following: furnishing supplies which are not part of the Equipment or furnishing material therefore; electrical work external to the Equipment; work or supply of material related to maintaining a proper environment at Customer's site; and/or providing any goods or services not expressly described in this Agreement as being provided by CenturyTel.

6. Software License. The Equipment may be or may contain software. In some cases the Equipment manufacturer (CenturyTel's vendor) has embedded such software into the hardware as an integral part of the Equipment. All software provided hereunder remains the property of, and full ownership shall remain vested in, the creator, developer, manufacturer, author or licensor, whichever the case may be. If required by the creator, developer, manufacturer, author or licensor, Customer must obtain a license to use such software, which license may contain specific terms and conditions for such use. These specific terms and conditions for use are governed entirely by said creator, developer, manufacturer, author or licensor and shall be adhered to by Customer. Upon the requirement of such creator, developer, manufacturer author or licensor, such license shall be executed by Customer as required and shall become a part of this Agreement by reference.

7. Miscellaneous.

- (a) The laws of the state of Montana shall govern the interpretation of this Agreement. If any of the provisions of the terms and conditions contained herein shall be held to be invalid or unenforceable in any jurisdiction in which these terms and conditions apply, such invalidity or unenforceability shall not invalidate or render unenforceable any other term or condition, but rather these terms and conditions shall be construed and enforced accordingly. In the event of any such invalidity or unenforceability of any provision, the parties shall promptly cooperate to replace such provision with a valid and enforceable provision that achieves the same result as the invalid or unenforceable provision, to the maximum extent permitted by law.
- (b) CenturyTel shall not be responsible for performance if its performance is prevented by acts or events beyond CenturyTel's reasonable control, including but not limited to power failures, electrical power surges or current fluctuations, nuclear or other civil or military emergencies, or acts of legislative, judicial, executive, or administrative authorities.
- (c) Any failure of a party to assert any right under this Agreement shall not constitute a waiver or termination of that right, this Agreement, or any of this Agreement's provisions.
- (d) Customer shall not assign or transfer any interest in this Agreement without the prior written consent of CenturyTel, which consent shall not be unreasonably withheld; provided, however, that CenturyTel may assign and/or transfer this Agreement to any parent, subsidiary, or successor, and CenturyTel shall have the right to subcontract all or any portion of its installation obligations hereunder to a third party.
- (e) The respective obligations of Customer and CenturyTel under these terms and conditions, which by their nature would continue beyond the termination, cancellation, or expiration hereof, shall survive termination, cancellation, or expiration hereof.
- (f) Except as otherwise provided in this Agreement, any notice or demand to be given under this Agreement shall be delivered in person or by United States certified mail, return receipt requested, and addressed as specified on Schedule A or to such other address as a party may specify in accordance herewith. Notice shall be effective upon receipt.
- (g) No provision of this Agreement shall in any way inure to the benefit of any third person (including without limitation the public at large) so as to constitute any such person a third party beneficiary of the Agreement or of any one or more of the terms hereof, or otherwise give rise to any cause of action in any person not a party hereto.
- (h) If any suit or action is instituted or prosecuted to interpret or enforce any provision of this Agreement, the prevailing party in such suit or action shall be entitled to recover from the other party costs, expenses and reasonable attorney fees incurred by such prevailing party in connection with such suit or action, in addition to all other sums allowed by law and this Agreement, both at trial and on appeal.
- (i) This Agreement may be executed in one or more counterparts, all of which taken together shall constitute one instrument. Each party to this Agreement agrees to accept a facsimile signature on behalf of the other party in lieu of an original signature; provided however, that either party may request, and the other party shall provide, an appropriate original signature following acceptance by such party of a facsimile signature.
- (j) This Agreement (which adheres to the terms and conditions of the Gallatin County RFP for 9-1-1 Customer Premise Equipment) represents the entire Agreement between the parties, is the final, complete exclusive statement of the provisions thereof, and supersedes and terminates any prior agreement, understanding, or representation between the parties with respect thereto, whether written or oral. Without limiting the generality of the preceding sentence, no provision of any purchase order or other document issued by Customer, whether before, on or after the date of this Agreement, shall modify or supplement in any way any provision of this Agreement.
