County agree to the following procedure to request response in areas defined as unprotecte				
within the boundaries of Gallatin County.				
For the call types selected in attachment A, in the areas defined below, Gallatin				
County makes a standing request for mutual aid from the Fire Department. In accordance				
with the Gallatin County Emergency Management Plan, the Gallatin County Sheriff's Office				
will serve as the Incident Commander.				
The Fire Department authorizes the Gallatin County 911 Center to dispatch the Fire				
Department on the receipt of any call type selected in attachment A that falls within the				
boundaries of the described unprotected area.				
This agreement remains in effect until canceled by the County or the Fire Departme
